### Entry Fee

\$50 per person

*The Tournament Committee reserves the right to refuse application or entry from any prospective entrant with or without cause. Any applicant refused entry will be entitled to a full refund of the entry fee. All tournament entrants and participants must be willing to submit to a polygraph. Results of the polygraph are final. Violators will be banned from future participation in this tournament.*

### GENERAL

1. All contestants must have paid their \$50 entry fee by 8:00PM Oct 7, 2011 the day before the tournament. Committee members will be at the Captain's Party till 8:PM to receive entries.
2. The tournament begins at 6:00AM unless threatening weather is present. (see Safety & Weather)
3. There are no boundaries. All waters fished during the tournament shall be legally accessible to the general public.
4. All fish must be caught by pole or rod and reel in strict adherence to State Laws.
5. No bait acquired by illegal means, no pre-baiting fishing spots and no culling of dead fish.
6. Each entrant may weigh in a fish in each category (trout, redfish & flounder) but is eligible for only one individual award. This is an "Individual Type" tournament and pooling or sharing of fish is not allowed.
7. Entrants are subject to random polygraph testing. You must be present within 15 minutes if called for a test or you will be disqualified.
8. The winner is determined by the heaviest weight. In the event of a tie, the fish weighed in first wins.
9. Violation of any rule or un-sportsman like conduct will disqualify the entrant.
10. A written protest, accompanied by a \$50 cash fee, may be filed with the tournament director no later than 4:PM on the day of the tournament. The fee will be refunded if the protest is judged valid.
11. The decision of the tournament committee, consisting of the tournament director and his appointed committee concerning any tournament matters is final.

### WEIGH-IN

1. The weigh station is located at Matagorda Tournament Pavilion at the Harbor Marina, Matagorda.
2. The weigh-in station will open at 2:PM and close at 4:PM the day of the tournament. To weigh in your fish, you must be inside Matagorda Harbor by 4:PM.  
NO EXCEPTIONS!
3. Contestants must appear in person and verify each entry by signing the register.
4. All fish will be weighed on the same scale
5. The largest fish in each category will be chosen by the contestant, weighed in one time and marked by the weigh master.
6. Any entrant who attempts to enter a fish that is not of legal size will be disqualified. No redfish over 28 inches will be accepted. All

fish must be caught by registered tournament entrants, during tournament hours, on the day of the tournament.

7. PARKS & WILDLIFE FISHING LICENSE & SALTWATER STAMP ARE REQUIRED. ALL PARKS & WILDLIFE RULES & REGULATIONS APPLY.

8. All fish submitted for weigh-in must be in a fresh, edible condition. Frozen, thawed, spoiled or mutilated fish, or fish altered from its natural state will be disqualified. The weigh master has the option to retain the fish for inspection and future reference. Weigh master's decision is final!

### SAFETY & WEATHER

1. If threatening weather is present, the tournament start may be delayed. The decision to delay the start time will be made by 6:AM. It is the responsibility of the contestants to verify the status of the tournament by contacting Russell's Bait & Tackle at 979-863-7620.
2. If severe or threatening weather compels the tournament committee to cancel the tournament, the tournament will not be rescheduled. A \$30 refund will be given to each entrant. \$20 per entrant will be retained to help cover the cost of the tournament. All side pot money will be refunded.
